

**NEW REGULATIONS AND PROCLAMATIONS UNDER THE WASTE-FREE ONTARIO ACT, 2016**

The Ministry of Environment and Climate Change is moving to implement its new waste diversion legislation, the *Waste-Free Ontario Act, 2016* (WFOA).

On June 9, 2016, the Act – including its two scheduled statutes, the *Resource Recovery and Circular Economy Act, 2016* (RRCEA) and the *Waste Diversion Transition Act, 2016* (WDTA) – received Royal Assent. However, no regulations were made under them, and none of the statutes were proclaimed.

**New WDTA Regulations**

On November 24, 2016, Ontario made the following seven new regulations under the WDTA:

In broad summary, the new regulations do one or more of the following: repeal an old regulation; designate as waste the relevant used materials; specify board composition of the IFO in question; establish formulas for the calculation of stewardship fees.

By virtue of the commencement wording in each of these regulations, they do not become effective until section 73 of the WDTA is proclaimed – on November 30 (see below).

### Proclamations

On November 30, 2016, most of the provisions of the two scheduled statutes will be proclaimed.

All of the RRCEA will be proclaimed, except section 33 – the requirement that the new Authority submit a Business Plan to the Minister – that comes into effect January 1, 2017.

Also, on November 30, 2016, most of the WDTA will be proclaimed, except sections 56-64, which will be proclaimed on May 1, 2017. The excepted provisions are those which will give the Authority the power to issue administrative penalties against transitioned Industry Funding Organizations, as well as giving IFO's the right to appeal such penalties to the Environmental Review Tribunal.
